GENERAL RULES

REGISTRATION FEE

ADR-Mediation Competition

- 1) The registration fee for ADR-Mediation Competition Participants who opted for accommodation facilities shall be Rs. 3,000 per team.
- 2) The registration fee for others shall be Rs. 1,500 per team.

Client Counselling Competition

- 1) The registration fee for Client Counselling Competition Participants who opted for accommodation facilities shall be Rs. 2,500 per team.
- 2) The registration fee for others shall be Rs. 1,500 per team.

Other Events

Registration Fee for all other events is Rs. 250 per person.

Note: Registration Fee once paid is not refundable under any circumstances.

FOOD & ACCOMMODATION*

Teams registered for the Mediation Competition and opted for Accommodation shall be provided food and accommodation only from 9th December, 2019 (evening) till 10th December, 2019.

Teams registered for the Client Counselling Competition and opted for Accommodation shall be provided food and accommodation only from 10th December, 2019 (evening) to 11th December, 2019.

**Note: Accommodation will not be provided to participants of other events.*

TRAVEL

Only outstation students (>50KM) shall be provided with travel facilities, i.e. to and fro the program venue and their respective places of accommodation, and not elsewhere.

RULES & REGULATIONS OF ADR-MEDIATION COMPETITION

Date: 10th December 2019

Time: 09:00 AM

REGISTRATION

- 1) The teams should register their details at the Register Desk before 08:30 AM.
- 2) By registering, the team shall be bound by the rules and regulations of this event.

OVERVIEW

- 3) The Mediation Competition will consist of two sub-competitions:-
 - a. Mediators' Competition; and
 - b. Client and Advocate Competition.

There will be no competition for Best Team as such; however, the competition will be for a 'Best Mediator' and 'Best Client-Advocate'.

- 4) All the General Rules applicable to other competitions with respect to discipline and decorum will apply to the Mediation Competition as well.
- 5) The allocation of participants and teams will be solely up to the discretion of the ADR Organizing Committee. Grievances, if any, may be raised to the Secretary, Moot Court Society, Government Law College, Kozhikode, and the decision in that regard will be final and binding.
- 6) The Problem for the Preliminary Round will be published 2 days prior to the date of the Competition, and intimation to such effect will also be sent to the teams who have registered *in toto* or provisionally. Similarly, the Problem for the Semi-Final and Final Rounds will be published prior to the Competition.
- 7) No written submissions will be required at any stage of the competition.

STRUCTURE OF COMPETITION

- 8) A Mediation Session will be presided by 2 Mediators (Co-Mediators) and on both sides, 2 pairs of parties to the dispute consisting of a Client and Advocate on each side. The 2 Mediators will Co-Mediate the session with an objective of solving the dispute between the parties. The Client and Advocate Teams, who are representing the parties to the dispute, will aim at amicably resolving their differences in the presence of the Mediators.
- 9) In every Round, there will be on the table, a General Set of Facts (Facts) and Confidential Information (C.I.). The Facts shall be known to the Mediators as well as both the Client and Advocate Teams. The C.I. shall be known only to the Client and Advocate Teams to which the information applies to. Both the Client and Advocate Teams will therefore have different set of C.I.s. The Co-Mediators' primary role is to facilitate an agreement between the parties to the dispute and further, to be able to address all their issues and reach an amicable solution.

CODE OF CONDUCT

- 10) The official language of the Competition shall be English.
- 11) The Participating Teams should mention only their allotted Team codes for the purpose of communication with Judges / Organizers. The identity of the Participating team or the name of their College / University shall not be disclosed to any other person during the course of the Competition. In addition, sporting any visible or distinguishable badges / card / uniform by any participant which provides an opportunity of inferring / disclosing their identity or the identity of the College / University being represented is forbidden.
- 12) The teams shall uphold the integrity of the Competition at all times and any scouting, disclosure of confidential information or any other unethical/unprofessional conduct is strictly barred; the practice of the same shall result in immediate disqualification. Any attempt to obtain the

confidential information or any other information from any of the parties may give the team an unfair advantage in the competition will result in immediate expulsion of the team and blacklisting of that college.

13)The use of any electronic gadgets is strictly prohibited during the rounds and the same may lead to disqualification of the teams.

14)All the participants are to adhere to Western Formals style of Dressing.

ANTI-SCOUTING POLICY

15)Scouting in all forms are strictly prohibited. Participating Teams will not be allowed to observe the Sessions of any other team(s) taking part in any event.

16)The teams are not allowed from contacting an external source after the disclosure of the problem or / and Confidential Information.

17)Scouting shall result in immediate disqualification and any decision of the ADR Board in this regard shall be final and binding upon the Participating Team.

COMPOSITION OF TEAMS

18)Every Team representing their institution shall consist of 3 participants – a Mediator; a Client and an Advocate.

19)Switching of roles between Mediators, Clients and Advocates is strictly prohibited throughout the competition. However, Client and Advocate roles may be allowed to switch their roles for a single time throughout.

Example: If A, B, and C are the Mediator, Client and Advocate respectively; A will not be allowed to switch and take up the roles of Client or Advocate. On the other hand, B and C will be allowed to switch the roles of Client or Advocate only for a single time at the beginning of any one Round of the Competition only.

ANATOMY OF A MEDIATION SESSION

20)Every Mediation Session shall extend to a maximum of 40 minutes. The main stages of each session include:

- a. Opening Statement of Mediators (2 minutes each);
- b. Opening Statements of Client and Advocate Teams (2 Minutes each);
- c. Setting up of Agenda¹ (2 minutes for each Mediator);
- d. Dispute Resolution and Caucuses² (20 minutes);
- e. Closing Statements of Client and Advocate Teams (2 Minutes each);
- f. Closing Statement of Mediators (2 minutes each)

(1) – **Agenda:** Agenda is the set of issues upon which the Dispute Resolution and Caucuses will revolve around. Each Mediator will approach the white board and ask the parties to raise issues to be added to the Agenda. Each Mediator can admit only up to a maximum of 3 issues during the initial setting up stage of the Agenda. However, during the Dispute Resolution and Caucuses stage, if the initial issues seem inadequate, further issues may be raised at the discretion of any Co-Mediator, if necessary.

(2) – **Caucus:** A Caucus is a meeting held by the Mediator with only one party to the dispute; the other party shall leave the room. During a Caucus, the party can clarify their positions, interests, and strengthen their objectives and strategies. Although it is the Mediators' discretion as to when to call for a Caucus, the Mediators have to call for a caucus at least once during the Dispute Resolution and Caucuses stage. Some rules relating to Caucuses are:

- A Caucus will occur between the Mediators and one Client and Advocate Team at a time.
- During a Caucus, the other party shall leave the room. It is absolutely necessary that the party that has stepped outside of the room maintains confidentiality and does not discuss anything relating to the dispute with any person whatsoever. If any party is found discussing anything related to the dispute with anyone, the ADR Organizing Committee has the right to disqualify such team(s).

TEAM PROGRESSION

General Note: It is not necessary that the teams registering together as Mediators and the Client-Advocate will progress to the next rounds together as well. Progression is based on points scored by Mediators separately and the Client-Advocate teams separately.

21) Preliminary Round - In the Preliminary Round, 16 Mediators and Client-Advocate Teams each will compete for qualification to the next round. Thus, there will be 8 Mediation Sessions wherein 2 Mediators (Co-Mediators) and 2 Client-Advocate Teams will participate in each session. Out of the 16 participating Mediators and Client-Advocate Teams, 4 Mediators and 4 Client-Advocate Teams each will progress to the next Round.

**Note: Due to shortage of time, there will be no Quarter-Final Round.*

22) Semi-Final Round – In the Semi-Final Round, 4 Mediators and Client-Advocate Teams each will compete for qualification to the Final Round. Thus, there will be 2 Mediation Sessions where again, 2 Mediators (Co-Mediators) and 2 Client-Advocate Teams will participate in each session. Out of the 4 participating Mediators and 4 Client-Advocate Teams, 2 each will progress to the Final Round.

23) Final Round – In the Final Round, 2 Mediators and Client-Advocate Teams each will compete for victory as the 'Best Mediator' and 'Best Client-Advocate' respectively. The structure of each session will be as mentioned above.

Note: *The Preliminary and Semi-Final Rounds will NOT be knock-out rounds. Progression will be based solely on the scoring criteria. Only the Final Round will be a knock-out round.*

RULES & REGULATIONS OF ESSAY WRITING COMPETITION

Date: 10th December 2019

Time: 10:00 AM

OVERVIEW

- 1) This is an individual competition. Any number of participants from any institution (Law Schools or otherwise) are allowed to participate in the Essay Writing Competition.
- 2) Strict decorum has to be maintained. Any malpractice on behalf of any of the participants will lead to disqualification.

STRUCTURE OF THE COMPETITION

- 3) The duration of the competition is 1 hour.
- 4) The topic will be given immediately before the commencement of the competition.
- 5) Topics will be based on current socio-legal issues of grave importance.
- 6) Scoring criteria will be based entirely on the discretion of the Judges/Evaluators.
- 7) In cases of any disputes, the decision of the Organizing Committee will be final.

RULES & REGULATIONS OF CLIENT COUNSELLING COMPETITION

Date: 11th December 2019

Time: 09:00 AM

OVERVIEW

- 1) Each team shall consist of two members only.
- 2) The teams will be selected on 'first come first serve basis. Maximum Number of teams which can register in the Client Counselling competition is 16 teams.
- 3) Dress Code- Formal Moot Court attire.
 - Ladies:** White salwar and kurta or white shirt and black trousers or skirt along with black coat and black shoes; and
 - Gentlemen:** White shirt, black trousers along with black coat and black shoes.
(Suit Jacket/Blazer is optional but only black color will be permitted.)
- 4) Participants shall not reveal his or her identity in any way.
- 5) All the problems will be based on subject matter, involving the following areas:
Law of Contracts, Consumer Law, Constitution Law, and other codified and un-codified laws relevant to the theme.
- 6) The official language of the Competition shall be English.

TEAM FORMATION

- 7) Each team shall consist of two student participants.
- 8) Teams cannot be changed or altered after registration. Any change or alteration in the registered team is subject to the sole discretion of the Organizing Committee.

- 9)** Team codes shall be allotted to the respective teams by the Organizing Committee which shall be used to identify the team throughout the competition.

CODE OF CONDUCT

- 10)** Participants are to conduct themselves with the required etiquette during the span of the entire competition. Reckless or irresponsible behavior by any of the team members may result in the disqualification of the entire team.
- 11)** All and any grievances are to be presented only to the organizing committee of the Competition.
- 12)** Participants shall not reveal their identity or that of their Institution/University to any judge or participant during the course of the competition. In order to preserve anonymity, each team will be identified by a code, which will be provided to each team during registration process. Disclosing the name of the participating college to the judges will result in a penalty.
- 13)** Any attempt to obtain the information about client or his/her problem before the commencement of the rounds shall again render a team liable for disqualification.
- 14)** The Judges and the teams shall agree beforehand to the commencing time of the interview. Failure to adhere to any of the time limit will result in a penalty against whomsoever the delay is attributable to.
- 15)** Scouting is prohibited and will result in a penalty¹

REGISTRATION

- 16)** The teams should register their details at the Register Desk before 08:30 AM.

¹ The penalty will be decided by the Judges/Organizing Committee.

17) By registering, the team shall be bound by the rules and regulations of this event.

FORMAT

18) Each team shall consist of two student participants and would be allotted a room for the interview and counselling. Here, the two student participants will present themselves as advocates in a lawyer's chamber. The client will be a person trained by the organizers and the advocates will counsel the clients regarding the given problem. The two participants are required to elicit all relevant information from the client by interviewing or questioning the client and then counsel the client.

19) All teams will be given their tag numbers by the organizers by picking of lots.

20) The Competition is divided into three rounds, namely: Preliminary Round, Semi Final Round & Final Round. (Quarter Final Rounds will be included, at the discretion of the Organizing Committee.)

21) After the Preliminary Round the top 8 scoring teams shall move forward to the Quarter Final Round.

22) The top 4 scoring teams shall then move forward to the Semi- Finals Round.

23) Two highest scoring teams from the Semi Final round shall enter the Final Round. Thereafter, the highest scoring team among the finalist teams will be titled as the Winner of NOMIKÓS PÓLEMOS Law Fest 2019 Client Counselling Competition.

Total Time Period – Client Counselling Session:

24) The whole Client Counselling Session shall be for 20 minutes in the Preliminary and Quarter Final Rounds. As regard to the Semi-Final and Final Rounds, the

session will last for 35 minutes. The Quarter Final Round, if held shall follow the same time period of the Preliminary Round. The whole session will be divided into consultation period and post- consultation period, the details of which are given in Point 8 and Point 9 respectively. The participating teams shall adhere to this time limit in every circumstance.

The Consultation Period (Interview Period):

25)The first 15 minutes in the Preliminary and Quarter Final Rounds and 25 minutes in Semi-Final and Final Rounds are devoted for consultation with the client during which lawyers are expected to elicit the relevant information, outline the problem and propose a solution or other means of resolving the problem. (Further information is contained in the Judging Standards for the Client Counselling Competition.) Participants may either use English or Malayalam to communicate with the client during the Consultation Period. During the consultation and post- consultation, the teams may use books, notes and other materials.

Post Consultation Period (Post Interview Period):

26)The remaining time from the total time as specified above will be for post consultation period i.e. the last 5 minutes in the Preliminary and Quarter Final Rounds and last 10 minutes in Semi-Final and Final Round are devoted for post consultation. During the post consultation period, the team members may either talk to each other loudly enough to be overheard by the judges, or dictate a file memorandum on the interview, or both.

27)The concept behind the post-consultation period is to summarize the interview, indicate the scope of the legal work to be undertaken, and state the legal issues that should be researched. Explanation of the position or attitude taken by the team members may be useful. Judges may question the teams during the post consultation period.

- 28)** If the students feel that some documents are appropriate, they may dictate such a document at the post consultation stage.
- 29)** The Judges may penalize participants who allow the interview session to run excessively beyond the 15/25 minute period allotted in the rules. However, the judges in their discretion, taking into account the circumstances, may allow some more time beyond the 15/25 minute period for the interview session. If the extended consultation session allowed an opportunity for a team to gather more information than other teams, this circumstance should be taken into consideration by the judges in making their decision.
- 30)** The Final Round will consist of a single panel of judges. After the judges have seen both the teams' performance, they should discuss each team's performance among themselves. The judges can discuss with the teams regarding their performance. Then judges will individually rank the teams.

JUDGING STANDARDS

- 31) Establishing the working atmosphere.** The lawyers established the beginning of an effective professional relationship and working atmosphere and at an appropriate point oriented the client to the special nature of the relationship in a courteous, sensitive and professional manner.
- 32) Description of the problem.** The lawyers learned how the client viewed his or her situation, using a combination of listening and questioning, drawing out both information and feelings, as appropriate, to develop a reasonably complete and reliable description of the problem and reflecting this understanding to the client. In this regard, relevant information voluntarily said by the client could be elicited by asking relevant specific questions.
- 33) Client's goals, expectations and needs.** The lawyers learned the client's goals and initial expectations and modified or developed them as necessary,

giving attention in doing so to all aspects of the problem, including the emotional ones.

34)Problems Analysis. The lawyers analyzed the client's problem with creativity and from both legal and non-legal perspectives, resulting in a clear and useful formulation of the problem by asking relevant specific questions.

35)Legal analysis, alternative courses of action and giving of advice. Legal analysis and the consequent legal advice given should be both accurate and appropriate to the situation and its context. Consistent with the analysis of the client's problem develops a set of potential and feasible alternatives, if any, both legal and non-legal.

36)Client's informed choice. The lawyers, having developed a set of potentially effective and feasible courses of action consistent with the analysis of the client's problem, assist the client in his or her understanding of the problems and solutions and in making an informed choice. Potential legal, economic, social and psychological consequences should be taken into account.

37)Effective conclusion. The lawyers concluded the interview skillfully, and left the client with feeling of reasonable confidence and understanding, with appropriate reassurance, and with a clear sense of specific expectations and mutual obligations to follow.

38)Team work. The lawyers as collaborating counsels, worked together as a team, with flexibility and an appropriate balance of participation.

39)Continued an ethical and professional relationship throughout the interview. The lawyers recognized, clarified and responded to any moral or ethical issues which may have arisen, without being prejudicial in judgements. The lawyers developed an appropriate balance in dealing with the legal and emotional needs of the client.

40)Debriefing (Post interview Reflection). The lawyers, during the post consultation time, gave evidence of having recognized their own and the client's feelings; the strengths and limitations of their interviewing skills; their

handling of the substantive aspects of the client's problems (both legal and non-legal); the quality and appropriateness of their advice and provided for an effective follow-up. Judges should expect to see evidence of participants learning through making this reflection on the experience of the interview.

MISCELLANEOUS

41) If a tie persists, the team scoring the higher marks as according to the Point 36 of Judging Standard, will be entitled to move forward to the next round. If a tie still persists, the marks of the tied teams will be compared with respect to the following Points in the Judging Standards, until either of the team come out as a clear winner:

- Point 35, if still a tie, then
- Point 34, if still a tie, then
- Point 39, if still a tie, then
- Post Consultation Session with the Judges (of 10 minutes each)

42) Participants may use their own Bare Acts and basic stationery items for use during the rounds. No resource material shall be provided by the organizing institute.

43) Use of electronic gadgets like laptop, tablets, mobile phone, etc. shall not be allowed during the rounds. It may result in disqualification.

44) The participants shall maintain the expected standards of a professional and behave accordingly during the competition.

45) The decision of the judges with respect to the results of each round shall be final and binding.

46) The organizers may change parts of the rules or format of the competition, without any prior intimation, but every team shall be informed about the change.

47)The decision of the organizers shall be final in any matter including circumstances not envisaged in the rules and regulations of the competitions.

RULES & REGULATIONS OF JUDGEMENT WRITING COMPETITION

Date: 11th December 2019

Time: 12:00 PM

REGISTRATION

- 1) The teams should register their details at the Register Desk between 12:00 PM and 13:00 PM.
- 2) By registering, the team shall be bound by the rules and regulations of this event.

OVERVIEW

The Judgment Writing Competition is a good platform for students of law to think and act in the brains and shoes of a Judge of the lower judiciary. The competition encompasses a research time, wherein the participants can use the Library to research upon the case given to them. This ensures a better degree of quality in the judgments delivered. Participants can use this opportunity to gain wide knowledge of that aspect of law as well as hone their skills in deciding cases.

NATURE OF THE COMPETITION

- 3) Judgment Writing will be an individual competition. No participant will be allowed to discuss with anyone during the competition.
- 4) Every participant is assumed to be a Judge of a Civil/Criminal Court having competent jurisdiction to try the case at hand.

STRUCTURE OF THE COMPETITION

- 5) Upon reporting, the participants will be given a legal problem and a summary of the hearings pertaining to that problem.

- 6) Participants will have 10 minutes for a *prima facie* reading and comprehension of the case.
- 7) The participants will be then guided to the College Library, where 1 hour and 30 minutes time will be given for researching upon the case and collecting relevant material to formulate a judgment.
- 8) Participants will not be allowed to carry any smartphones or other gadgets, but only the notepads provided.
- 9) Participants will then be guided back to the Venue where 1 hour will be given to write a judgment for deciding the case.
